We will endeavor to keep you informed of any changes in shipping schedules.

- 6. CLAIMS All claims for defective material, shortage. etc., must be made within 3 days after receipt of goods. The material must be held for our inspection and cannot be moved or disposed of without our written authorization. No merchandise may be returned without written authorization. All returns are subject to a 15% restocking fee.
